

PEACE RIVER REGIONAL DISTRICT
By-Law No. 1587, 2005

A by-law to amend Charlie Lake Fire Protection
Service Area Establishment By-law No. 1360, 2001

WHEREAS, the Board of the Peace River Regional District by "Charlie Lake Fire Protection Service Area Establishment By-law No. 1360, 2001" established fire protection services within the defined portions of Electoral Areas 'B' and 'C';

AND WHEREAS the Board wishes to increase the requisition limits for the service to enable the Regional District to negotiate new contracts with the Charlie Lake / Grandhaven Fire Protection Society;

AND WHEREAS the Board has received the assent of the electors within the defined portions of Electoral Areas 'B' and 'C';

NOW THEREFORE the Board of the Peace River Regional District, in open meeting assembled, enacts as follows:

1. "Charlie Lake Fire Protection Service Area Establishment By-law No. 1360, 2001" is amended by removing Section 4 and substituting the following:

"Requisition Limitation"

4. The maximum amount that may be requisitioned under Section 3 for the service provided under Sections 1 and 2 shall be the greater of:
 - a) \$450,000; or
 - b) the product of a property value tax of \$1.57 for each \$1,000 of net taxable value of land and improvements included in the service area."

2. This by-law may be cited for all purposes as "Charlie Lake Fire Protection Service Area Establishment Amendment By-law No. 1587, 2005."


