PEACE RIVER REGIONAL DISTRICT
Bylaw No. 2483, 2022

“A bylaw to establish fees and charges for miscellaneous
Peace River Regional District Services.”

WHEREAS the *Local Government Act* provides authorization to Regional Districts to impose fees for all or part of a service of the Regional District, or for the use of Regional District property;

AND WHEREAS the Regional Board deems it necessary to establish fees for a variety of services provided by the Regional District;

NOW THEREFORE, the Regional Board of the Peace River Regional District, in open meeting assembled enacts as follows:

SECTION 1 – GENERAL PROVISIONS

1. This bylaw may be cited as “Miscellaneous Fees and Charges Bylaw No. 2483, 2022”.
2. If any portion of this bylaw is declared invalid by a court, the invalid portion shall be severed and the remainder of the bylaw is deemed valid.
3. The headings used in this bylaw are for convenience only and do not form part of this bylaw, and are not to be used in the interpretation of this bylaw.
